Discipline

Power Haus Sports and Learning Academy Inc. and the State of Illinois prohibits:

- A. Corporal punishment, including hitting, spanking, swatting, beating, shaking, pinching and other measures intended to induce pain or fear;
- B. Threatened or actual withdrawal of food, rest or use of the bathroom;
- C. Abusive or profane language;
- D. Any form of public or private humiliation, including threats of physical punishment; and
- E. Any form of emotional abuse, including shaming, rejecting, terrorizing, or isolating a child.

Whenever possible, firm positive statements about behaviors or redirection of behaviors will be used. If; however, a removal from the group to help a child gain control is needed the separation will not exceed one minute per year of age. For example: If a child is three, the time out will be for no more than three minutes.

Physical or verbal abuse of other campers or counselors is not acceptable: physical violence, foul language or gestures, and stealing are also unacceptable.

Yellow	Fouled out...a brief separation from the group
Blue	Bad news...a note to parents to be signed and returned
Red	Worse news...meeting with parents will be required
Black	The worst news...the child will be permanently removed from the program

Positive Reinforcement

Positive reinforcement will be used in our programs. It will be based on the child’s behavior for the day. It includes, but is not limited to: verbal praise, awards, high fives and field trips.

Arrival and Departure

Transportation to PHSLA is provided by the parent or guardian. Please sign by your child’s name and write time of arrival and departure on the sheets provided. **Children will only be released to those listed on the enrollment form.** Transportation for After School Sports Shorts will be provided by Durham Bus Services.

Late Pick Up Policy / Fees

Power Haus reserves the right to notify the police or a social service worker if a child has not been picked up by 6:30 p.m., without prior notification from a parent or guardian. We will try the numbers provided on the child’s enrollment form. Within that thirty minute period our staff will attempt the numbers five times before we proceed with further action. There will be a grace period of 5 minutes, after which we will add \$1.00 per minute that your child isn’t picked up.

Early Termination Policy

Power Haus requires a two-week notice if your child will be leaving Power Haus. Whether your child attends or not during those two weeks, the fees will still apply.

Field Trip

- A. Agree that prior to participating they will inspect the facilities and equipment to be used and if they believe anything is unsafe, they will immediately advise management of such condition(s) and refuse to participate.

Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death and severe social and economic losses which might result not only from their actions, inactions, or negligence of others, the rules of play or the condition of the premises or of any equipment used. Further, that there may be other risks not known such as injury, permanent disability or death.
